## SCOPE & SUPPLIERS

In summary, the Goods comprise of the supply of Print Books and Audio-Visual Material to all public libraries within the twenty-nine local authority library services. The LGMA is seeking vendors that can supply books and AV material that reflect the Irish, UK and international publishing industry including bestsellers, new titles and back catalogue.

The framework agreement is divided into Six (6) lots as follows, with a Single Supplier (each a “Framework Member”) appointed to the Framework Agreement for each Lot as follows;
